TERMS AND CONDITIONS:

Country Celebrations Event Center will strictly enforce federal laws and will maintain a zero tolerance compliance policy that no alcoholic beverages can be consumed or used by any person not of legal drinking age. All state and federal drug, alcohol, and weapons laws need to be followed while being transported in any of our vehicles. All U.S law enforcement agencies have absolute power to stop any motor vehicle for administrative searches. If contraband is found aboard, they can seize and forfeit our vehicle to a local government agency. Therefore, no person will bring contraband aboard vehicles that are owned and operated by Country Celebrations. Country Celebrations Event Center will not be responsible for any injuries that may occur due to horse playing while the vehicle is in motion, at a

standstill or entering and exiting vehicle. The purchaser on the front of this contract is solely responsible for his or her guests.

Country Celebrations recommends that any and all personal valuables be removed from the vehicle when unattended. Country Celebrations Event Center will not be held responsible for any lost, stolen or damaged articles in or on our Buses. Country Celebrations Buses reserve the right to terminate this or any other contract for noncompliance of the above/below requests, especially if renters do not follow chauffeurs requests in order to obey the rules in this contract. All of the given information from the renter is binding and cannot be changed without Country Celebrations Event Center acceptance.

Any damage to the interior or exterior of the bus or equipment that is caused by an individual riding in the vehicle is the responsibility of said individual, and said individual is liable for the cost to repair any such damage as well as any cost for loss of the Country Celebrations Buses service due to such damage. **Country Celebrations Bus driver and/or employee reserves the right to eject any individual(s) whom they deem to be disruptive, intoxicated, to pose a safety threat to themselves or to others, or deemed to be using an illegal substance.**

By signing up for and participating in the ride the individual agrees that he/she, if intoxicated, will not operate a motorized vehicle after leaving the party bus. By signing up for and participating in the ride, the individual agrees that Country Celebrations employees are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.

All deposits are non refundable. **The purchaser is responsible for the payment of the total amount, via credit card, cash or check. If the purchaser cannot provide all of the above items at the time of the pickup, Country Celebrations Buses will not start the job.** Therefore, the risk of not getting paid will give us the right to cancel. The purchaser is still fully responsible to pay the total amount if he/she fails to provide the above requirements. If the Bus Rental is in conjunction with an event at Country Celebrations Event Center, you may pay for any remaining Bus rental amount after the end of the event. Country Celebrations Event Center shall not be held responsible for late arrival caused by (but not

limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop off information, or any situation beyond our control.

Non Alcohol Transportation

If rental is for non alcohol transportation only, this means that **no guest** can drink on the bus. If a guest does consume alcohol on the bus, you will be charged all of the party bus hourly rates and all minimum rates.

Country Celebrations Event Center agrees to send the requested vehicles as offered in the contract. We have the right to switch the vehicles in case of emergency breakdown or if the vehicles are damaged.

By signing up for and participating in the ride the individual agrees that he or she is of age to consume alcoholic beverages responsibly while in the party bus. **If, at any time, passengers under the age of 21 are found to be in possession of alcohol or found to have been consuming alcohol during the course of service, the service shall be terminated. Any and all monies shall be forfeited. The driver has the option of returning to the point of pickup or ending the service at the point of infraction.**

Cleaning fee/ Damages

There is no smoking allowed on the bus at any time. A clean up fee of \$300 will be charged if any smoking did occur.

Additional charges may accrue due to damaged property, and/or excessive messes left behind. Charges for damages will be billed at the cost of materials, plus labor.

\$100.00 charge for the clean up of any bodily fluids not contained, and/or debris left behind that require extensive cleaning up.

Not responsible for any lost, damaged, and/or stolen personal property.

If the vehicle rental is to be for a minor under the age of (18) eighteen, this agreement must be signed by either a parent or legal guardian. Country Celebrations Event Center is not responsible for underage consumption of alcoholic beverages at any time before, during, or after the ride.

I, the purchaser, agree to pay the deposit or rental fee in full to Country Celebrations Event Center upon signing this contract. I am satisfied with

the terms and conditions above and fully understand and agree.
